I REMEMBER MY GRANDDADDY

I was six years old when Thomas Judson Dedmon (my granddaddy Dedmon) died. Dad had left for the Army on my birthday, June 27, 1945 when we receive word that Judson Dedmon had been hit by an automobile while crossing the street in Chattanooga, TN. The Red Cross located dad and transported him to Macon, GA where mom's cousin, Alex Dickson, took us to meet him and bring him home. Granddaddy died two days later on June 29, 1945. He would have been 65 years old had he lived until November. He was buried at Ebenezer cemetery in Ringgold, GA.

Here is his obituary taken from the Chattanooga paper:

1945, JUNE 30. Dedmon, Thomas Judson, 64 died in a local hospital Friday morning (June 29). He is survived by four sons, James and Woodrow Dedmon of Chattanooga, Paul Dedmon, Gordon Dedmon, Graysville, GA. Three daughters, Mrs. Robert (Edna) Capehart of Dalton, GA. Mrs. James (Ruth) Boyd Jr. and Mrs. Bill (Pauline) Turner of Chattanooga. Eleven grandchildren, two sisters, Mrs Tom Ezell of Trion GA. and Mrs. Emory Campbell of Tunnel Hill, GA. Funeral services will be held Sunday afternoon at 3 o'clock at the Ebenezer Baptist church, conducted by the Revs. P.S. Woody, John W. Cummings and Edward E. Grant, burial will be in the Ebenezer Cemetery. The body is at the home of his son, James Dedmon, 1911 Beech St. Arrangements are by National Funeral Home.

Judson's first wife, Alice Walker died in 1918 during the influenza pandemic of 1918-1919 which killed more people than the Great War, known today as World War I (WWI), at somewhere between 20 and 40 million. My father was a baby only about 6 months old. My grandfather remarried in 1920 to Essie Orr, the widow of Charles McCalla. She had several children of her own and a couple of them were also infants. I don't know all the details, but my father was reared by his aunt, Toni Walker Cline. He told me he did not really know his father until he reached his teen age years and went by the name of Gordon Cline instead of Gordon Dedmon. Growing up, we visited the Cline family often.

In fact, I attribute that to the reason we were not real close with many of the Dedmon family members. I knew all of my Dedmon first cousins, but were never as close as my cousins on mother's side of the family. There were other Dedmon families in the Chattanooga area, but we never became acquainted. It was only after I began this research project they were discovered. Many of us have since become acquainted and enjoy a kinship deprived us as youngsters, However, as a result our children don't and probably never will know each other. Nor do I know very many of their children.



The only remembrance I have of my granddaddy Dedmon was a visit we made to a store where he was working in Dalton, GA. Thinking back, that may have been a visit for my dad to say good-bye before he left for the Army. I had to be close to six years old. The above picture is of a store he owned sometime around 1909 as Uncle James is in his mother's arms. I don't really have a clue as to the identity of these people.

On the bank of the river stood the old Grist Mill, the old wooden dam above it channeled the water to run the old mill.

There were many fine large rocks below the dam in shallow water at times. It was a place of scenic beauty and a place for picnicing, fishing and boating in the deeper waters. It was a popular gathering place for the young and old. The young people would try to walk across the river on the rocks and would many times fall for a good ducking. Once a boat load of young people overturned, but it was all fun.

People carried lunches and it was at this place with a small beginning that the big Masonic Picnic had its start.

The merry-go-round was built of wood and was horse drawn. It was made by my grandfather John T. Trollinger, who ran the Grist Mill. The man responsible for having the merry-go-round was A. T. Lefler, uncle of Mrs. J. G. Crawford.

John Trollinger, my grandfather, who ran the Grist Mill, lived in the Millers house, not far from the end of the dam. The house has since been moved to Riverside Drive and it still standing.

My grandfather bought a piece of land in the woods, now known as Cooleemee, and built his own house, the house on 59 Main Street and now known as the Jerry James house. He built this home in the clearing he had made around 1887. My mother, was the only child of John T. and Eliza Keck Trollinger of Alamance County.

Many times, I have heard my grandfather tell of these things, as I spent a great deal of my young days with them.

I can remember, too, when the builders of Cooleemee bought my grandfather's home, now 59 Main Street, but a room has been added to the right front. Those I remember were Mr. Murdock, Mr. Duke and Mr. Erwin.

My father, J. C. Dedmon, was a foreman in the building of the town and worked on the construction of the old Company Store, the Drug Store and made the disks first used in cotton mill. Following the sale of our home, I was born there in 1894.

A ferry was in use near "The Shoals" on the river and was operated at one time by Mr. William Nolley, grandfather, of Roy and Hubert Nolley of near Cooleemee.

Mr. Johnny Wagner, my husband's grandfather, William Dedmon, and others were land owners in this section of Davie County at the time.

I recently ran across this newspaper article written by the mother of a dear friend of mine, John Wagner. I met John when I moved to Beemen, GA to become the minister of the church there. At the time he was the treasurer. We developed a friendship that lasted till the day he died. At the time we did not realize we were fifth cousins, that came later with the research. I retyped the article to make it more readable.




DEDMON -WOODS EXCHANGE VOWS

ROBERT HENRY DEDMAN, SR.
(April 24, 1831 - March 03, 1899)



Robert Henry Dedman, Sr. was the son of Phillip and Mary Hawkins Dedman. He married Caroline "Carrie" Winstead on November 04, 1859 in Dallas County, AR. They had three children: Robert, Jr., Carrie Lea, and Philip Winstead Dedman. Caroline was born on April 05, 1841 in Pearson County, AR and died November 19, 1925 in Fordyce, Dallas Co., AR. SUDDEN DEATH

Friday morning, just at the day's dawning, a gloom was cast over our usually quiet village by the announcement that Judge R.H. Dedman, one of our oldest and most highly respected citizens, had been found dead in bed, at his residence in this place. He retired at his usual hour Thursday night, complaining of not feeling well, and at some hour during the night, without a struggle, and without waking, his wife, who slept by his side, his spirit took its departure. Imagine her surprise and horror when on awaking at five o'clock the morning, Mrs. Dedman found her husband lying cold in death.

Mr. Dedman had been suffering for some time from an attack of la grippe, but had so far recovered as to be able to be out and attending to business, and the evening before his death was on our streets laughing and talking in his usual lively manner, and no one thought death would claim him so soon, but for some time he has been troubled with heart disease, and a person so affected is liable to drop off almost at any moment.

At the time of his demise Mr. Dedman was 68 years of age, almost 40 years of which he spent in Princeton, having removed, before the war and when quite a young man to Princeton, from Alabama his native state.

Before the war he married Miss Caroline Winstead, and began in practice of law. At the opening of hostilities between the States he entered the Confederate army as Captain of a company, and served throughout the

war without receiving a wound from a Yankee weapon, although several times his clothing was pierced by bullets, and at one time his pants were literally torn to pieces by them.

His comrades in arms say that he made as brave a captain as ever buckled on a Sabre or charged an enemy, and that he knew no such a thing as fear.

After the war Capt. Dedman returned to Princeton, where he resumed the practice of law, and which he continued until he was elected Prosecuting-Attorney for this district, which he filled with great credit and ability. After serving faithfully as Prosecuting Attorney he was elected to other places of honor and trust, and always made an able, honest and efficient officer. Becoming too aged to serve as an official, he has for several years laid aside all aspirations to the practice of his chosen profession.

He was a strict member of the Methodist church, and for thirty years was superintendent of the Methodist Sunday School at this place. He was a public spirited man, and always made it a rule to encourage all enterprises and took a lively interest in everything looking to the welfare and the interests of our town, county and State; was always jovial in conversation, and will be sadly missed by our citizens who, by long association, had become almost as strongly attached to him as if he had been a father or a brother.

But in the wise dispensation of his providence, the Great Ruler of the Universe has seen proper to remove him from our midst, and we can but meekly bow and humbly submit to His decree, hoping that his spirit has reached the bright and shining shore "Where partings come no more", and has joined those who have gone on up through the "Great tribulation and have washed their robes and made them white in the blood of the lamb" in exclaiming: "Glory to God! All dangers are o'er, We stand secure on the glorified shore. Glory to God! We will shout evermore, We're home at last,"

Robert H. Dedman was the first in a line of five who bore the same name. It gets kinda confusing at times as Robert Henry Dedman IV is actually listed as Robert Sr. and Robert V. is Robert, Jr. (See Vol. 106) The son of Judge Dedman is also called Jr. but his son who would be Robert III is not designated with any suffix. So we end up with two sets of Robert Henry Dedman, Sr. and Jr. with just a Robert Henry Dedman in between, who is technically Robert H. Dedman, III (1897-1979).

NEAL PENNY, GOSPEL PREACHER

Elbert Neal Penny, of Trezevant, Tenn., died July 2, 1992. He was 69. He had served as a preacher for 50 years for congregations in Tennessee, Indiana, Michigan, and Louisiana. He attended Freed-Hardeman and David Lipscomb universities, respectively. He later served as a member of the advisory board of Freed-Hardeman University. A scholarship fund has been dedicated there in his honor. He is survived by his wife, Margaret [Dedmon]; a son, Stan; two sisters, Jimmy B. Taylor and Martha Bolin; and two grandchildren, Sherri and Kelly Penny. (Gospel Advocate, Nov. 1992, page 45).

Burial was in Walnut Grove Cemetery a short distance west of Trenton, Tennessee. Brother Penny is survived by his widow, Margaret Dedmon Penny of Trezvant, Tennessee; a son Stan Penny of Trenton, Tennessee, who is a highway patrolman; two sisters; Jimmie B. Taylor of Trenton, and Martha Bolin of Sidney, Ohio; and two grandchildren.

Education and Preaching

Neal Penny attended Freed-Hardeman College, and David Lipscomb College. He was a good Bible scholar, and loved the Lord, the word of God, and the Lord's church. He also loved the lost and preached the gospel of salvation nearly 50 years. He preached his first sermon at Christian Chapel in Gibson County, Tennessee. Margaret said he had his sights set on preaching there in January 1993 on the 50th anniversary of his preaching. At the time of his death, Neal was the regular preacher for Liberty Church of Christ near Dresden, Tennessee. He served as minister of churches of Christ in Gary, Indiana; Flint, Michigan; Dearborn, Michigan; and Monroe, Louisiana. He also served several other congregations in Tennessee, including: Bradford; Atwood, Sitka, Trezvant, and Dorris Chapel. It was my pleasure to preach in a series of meetings at Atwood when he was the preacher there. That was my closest association with him, and I learned to love and appreciate him very much. I was born and reared in that part of West Tennessee where he did most of his preaching. I always heard good things about him.

JAMES SHELBORN DEDMAN

VETERAN MASON PASSES AWAY

J.S. Dedman, died in Weiser, Idaho, Sunday, July 13, 1902, aged 89 years, 1 month and 25 days. He was born at Huntsville, Alabama on May 20th, 1819, to Philip and Mary Polly Hawkins Dedman. He is survived by his present wife, Melinda Snell. He had two previous marriages: Thelia Black (1837-1891) and Missouri Hilliard (1814-1854). He became a member of North Mt. Pleasant Lodge No. 99, A.F. & A.M., in 1840 and had been an active Mason for 61 years and 7 months, and but for the unnatural manner of his death would undoubtedly have lived to become one of the oldest Masons in the world. At the time of the breaking out of the Civil war he was a very wealthy man. The confederate government took charge of his foundry paying him in confederate notes. He has always had a trunk full of the purchase of his establishment. He cast the first cannon for the Confederacy and has two or three comrades now living near Weiser. He became a charter member of the Weiser lodge in 1887.

Mr. Dedman went through a severe attack of spotted fever a year ago and on recovery entered upon a period of hearty old age, bidding fair to live ten or fifteen years yet -- his father died at 98. Saturday he was around town attending the primaries and telling his friends how fine he felt. Sunday morning he arose and built the fire; a few moments later he came in and sank on the sofa calling to his wife "I am a dead man, I drank the carbolic acid instead of the wine." those were his last words. Mrs. Dedman ran to a neighbor's and telephoned for Dr. Waterhouse who arrived in fifteen minutes to find the old man dead. He was in the habit of taking a glass of wine in the morning and the bottle in some way had become misplaced and he had taken instead a glass of a wash containing a large amount of carbolic acid, the concoction having much the appearance of the wine. He was buried under the Masonic auspices, the ceremonies being in charge of D.C. Chace, Worshipful Grand Master of Idaho.


