It has been proven psychologically that names can and do affect ones personality.

Have you ever wondered why some names were so popular in the past generation(s) and are no longer used. The name Alonzo, was very popular a couple of generations back. I counted 20 in my database, and the last one was born in 1930. Actually there were two that I have listed, born that year. Harrison Alonzo Dedmond, the son of Eppy Alonzo Dedmon and Grady Alonzo Dedmon, the son of John Daniel Dedmon. That is not counting the names that seem to have come from Alonzo. The nickname "Lon" was very prevelant for those named Alonzo and then the name Lonnie began to be used. There is also some variations in the spelling, such as Alonso, Alfonzo and even Lonso. It has popularity in other languages. The following chart is interesting in that it shows what we have already surmised.



The popularity of the name Alonzo began to wane following the turn of the twentieth century. I am personally aquainted with a few named Lonnie, but the only Alonzo I know is Harrison Alonzo Dedmond.

County Judge Executive Milward Dedman Driving Mercer County Forward By Kristy Robinson Horine

He braces his outside leg and adjusts his seat toward the center of the ring to maintain balance in the curves. He stares directly between his horse's ears. His hands make small movements to control



movements to control **Dedman with Power Ranger** the reins and, from time to time, he sends a series of soft clucks to the animal before him. Some for reassurance, some for direction, all for the drive. From the center of the arena, the announcer calls the changes: jog trot to road gait, reverse direction, bring the horses to speed. At the last command, Milward Dedman's smile spreads and the crowd can feel the energy in the air. Dedman's green and white silks are in striking contrast to the brown dirt of the arena floor, the wheels of his bike spin as his horse edges faster forward. This is not about speed, this is about performance, about the grace of the right movement at the right time.

Dedman drives his roadster horse the same way he drives his life – proud and sure in his family's silks, changing gaits as the gaits are called, and staying on course, even when that course seems imperceptible to the crowd. Dedman remembers his first hackney pony, a small thing called Switchblade. He graduated from this road pony, to road horses, following in the footsteps of one of the most influential men in his life-Edwin Freeman. Freeman was widely known in many different circuits in Mercer County. He was co-owner of Freeman Brothers Stables, owner of Freeman Auction Company, and was the owner of Freeman and Mercer Tobacco Warehouses in Harrodsburg. In addition to all the business pursuits, Freeman also served the Commonwealth in the House of Representatives, the State Senate, as County Judge, and as a delegate to represent his home state beyond Kentucky's borders.

Freeman passed the drive to follow multiple pursuits to his only grandson, Milward Dedman, and, in true family style, Dedman simply picked up the reins. After graduation from Harrodsburg High School in 1983, he went on to the University of Kentucky and graduated in 1987 with a degree in communications and a minor in business and political science. "I sort of knew I was going to come back and go into the family businesses. I worked in all of them," he says. Dedman earned his real estate and auctioneer licenses and became part of what would eventually be called Freeman and Dedman Real Estate. He filled the real estate needs of the people of Mercer County during the spring, summer, and fall months of each year. During the winters, at least until the burley buyout in 2004, Dedman worked side by side with his grandfather in all facets of the warehouse operation. After warehouses started shutting down, due to a lack of price supports for the long-time crop, Dedman and Freeman made some difficult choices. No longer would the sweet smell of cured tobacco fill the air at the Freeman and Mercer Tobacco Warehouse.

"It was like a part of our family heritage left. From the time I was born, my grandfather had the tobacco warehouses and that was a part of who we were," Dedman says. "It just ended." What didn't end were the lessons passed on from grandfather to grandson. "The greatest lessons my grandfather taught me through working together at the warehouses are to be honest and be up front with people," Dedman recalls. "He was very goodhearted and he helped a lot of people. He loaned people money so they could grow the crop and they could pay him back after it sold. That just instilled in me how to help people." Those lessons on helping others came in handy long after the tobacco business faded away. While Dedman still worked as broker in the real estate office he and his grandfather shared, he turned his attention to another love, politics. "I was always interested in politics. I had kept up with elections and my favorite subject in high school was civics," Dedman says. "I liked the process. I didn't like some of the red tape with it, but I did like the process, the governing process."

Beginning in 2005, he served two two-year terms as a representative for the 55th House District. It wasn't long after he took his house seat, however, that he dis covered there needed to be a change on his part. "You almost have to be a part of the majority party in order to be able to accomplish anything in Frankfort. When I was in Frankfort, I was elected a registered republican and that was the minority party," he says. "I was basically conservative and after a while, I realized that there were conservative democrats, probably more conservative than I, and that in order to really be able to benefit the district that I represented, I had to be in the majority." While that switch might have cost him further elections, Dedman says his motivation for change was pure and didn't affect his relationships with the folks who really knew him. When he went out of office in December 2008, he returned to the real estate business.



Seven months later, Dedman received calls from both Governor Beshear's office and then County Judge Executive John Trisler. Trisler had announced his retirement and officials were looking to give Dedman the nod for the position. He nodded back and again picked up the political reins with the appointment from the governor in August of 2009. Dedman ran for reelection to the post and won against opposition in 2010.

"The judge I followed was a very intelligent man. His profession before county judge was as an executive at IBM. I had big shoes to fill," Dedman says, then speaks of how most people would see his political progression as odd. "The way I did things was kind of backwards. I went from Kentucky House of Representatives and then came back home to be county judge, but it has been the most beneficial thing that happened." During his four years in Frankfort, Dedman learned first-hand how the political system worked. He made friends and gained understanding. "I had contacts in Frankfort. I knew how county government worked and how they relied so much on Frankfort for funding and grants and all discretionary road funds and so it really helped," he says. He also got involved in regional governance, serving on the Executive Committee of the Bluegrass ADD. Leveraging the BGADD's support and the connections they provide, Dedman was able to successfully pursue and receive grants for a new water plant, an extension of the sewer service through the Mercer County Sanitation District, and the renovation of the Harrodsburg YMCA.

Today, Dedman says, it is nothing for him to pick up the phone and talk to the right person at the right time, driving the best course for the people who are dearest to him. Just like driving a roadster horse isn't about speed, Dedman says his county judge executive position isn't about speed, it's about the best performance for all involved. "The most important thing [in county government] is to keep the counties solvent. We don't have an abundance of revenue and we have to work within our means. We know what we are going to have coming in, and work with that budget," he says. "When I came in was right when we had the economic downturn and Mercer was fortunate that we had two major factories that had expansions: Hitatchi Auto and Wausau Paper."

Timing is everything. Without planning and proper execution of the water plant expansion, the infrastructure available to support the expansion for Wausau Paper would not have been adequate. Both companies brought major infrastructure expansions, they hired new employees and, while other communities might have been sitting idle, Mercer County fared well. In a rural county that doesn't see a large influx of new people every year, faring well is an accomplishment that Dedman is quite proud of. "We live in an age where people aren't hesitant about voicing their opinions. If your constituents are satisfied, people are going to tell you. If they don't like what you're doing, they are going to tell you," Dedman says. "I love Mercer County. When it is my turn to leave it, I would like to say I have left it in better shape than when I first got here." In the meantime, Dedman will straighten his back, take up the reins of the day and keep his eyes straight ahead, driving, always forward.

Facebook hires lawyer to oversee privacy policy

Facebook has moved to sharpen its image in relation to user privacy after recruiting a top lawyer from Vodafone who spearheaded the mobile phone company's disclosure report that lifted the lid on government spying on its network.



Stephen Deadman leaves Vodafone after 17 years but will remain based in London as he takes charge of Facebook's privacy policies across its global operations. His role will be deputy chief privacy

officer and he will report into Erin Egan, the chief privacy officer, who is based in Washington.

Stephen joined Facebook as Global Deputy Chief Privacy Officer in January 2015 to lead global privacy policy for Facebook internationally. Prior to joining Facebook, Stephen served as Global Privacy Officer and Head of Legal for Privacy and Security at Vodafone Group, where he founded the company's global privacy program and won the HP-IAPP Innovation Award for Privacy in 2012.

With over 18 years of experience in the technology and telecoms sectors, Stephen has worked on many of the emerging privacy issues including geo-location services, mobile advertising and analytics, identity management, big data, law enforcement and human rights, and spoken at many industry, privacy and security conferences around the world.

In 2005 Stephen was appointed European Chair of the Public Policy Expert Group of the Liberty Alliance, an industry alliance focused on building technology and business standards for federated identity management. In 2009 Stephen helped found and co-lead the Mobile Privacy Initiative, a global mobile industry initiative under the auspices of the GSMA, to create a privacy framework to advance privacy in the evolving mobile internet eco-system. Stephen has also played an active role in the protection of human rights in the ICT sector since 2005, working closely with civil society organisations, academics and ethical investors. He played an active role in the formation of the Global Network Initiative in 2008 and more recently helped found the Telecoms Industry Dialogue on Human Rights, announced in February 2013.

"I'm a lawyer by background and a privacy expert. Most of my career has been spent in industry, with the Vodafone Group and most recently Facebook.

At Vodafone, I helped to establish Vodafone's first global legal team, and over the course of over 10 years managed a series of teams focused on providing innovative legal and regulatory support to the business across 30+ countries in emergent areas such as mobile internet, m-commerce, and payments. One of the achievements I am most proud was supporting the foundation in 2007 of MPESA, the world's leading mobile money transfer service (http://en.wikipedia.org/wiki/M-Pesa).

In 2010, I founded the Vodafone Privacy Programme and the Global Privacy team. In that capacity, I led Vodafone to a number of awards, namely the HP / IAPP Innovation Award for Privacy in 2012, and the PRCA Award 2014 for Best international Campaign for Vodafone's inaugural Law Enforcement Disclosure Report.

I've also co-founded and helped to establish a number of industry initiatives and organisations, including the GSMA Mobile Privacy Initiative, the Global Network Initiative, and Telecommunications Industry Dialogue on Human Rights."

SHELBY-Mary Ruth Spangler Dedmon, age 88, of 1511 McBrayer Springs Road, Shelby, died Wednesday, July 27, 2016, at home surrounded by her family. She was a daughter of the late Abb Sylvester Spangler and Mittie Warlick Spangler. She graduated from Piedmont High School, Lawndale, and

Kings College, Charlotte. Following her graduation from Kings College, she was employed as a secretary, insurance clerk and bookkeeper. It was in 1956, however, that there was a dramatic change in her career. She was appointed by the late J.W. Osborne as a Deputy Clerk of Superior Court for Cleveland County. Shortly thereafter, she was reappointed as an Assistant Clerk. She served as Assistant Clerk for the next 13 years. In 1970, was elected to the office of Clerk of Superior Court where she remained without opposition for the next 20 years, until her retirement in 1990. She was the first woman to be elected to a constitutional office in Cleveland County.

During her professional career and subsequent retirement, she was a member of the NC Association of Clerks of Superior Court, during which time she was appointed by Gov. Bob Scott to the NC Manpower Council for manpower services and individuals in the criminal justice system; the only woman serving on this committee. She was also a member of the Cleveland County Juvenile Counseling Commission, Alcoholic Task Force, Head Start Policy Council, and The Cleveland County Mental Health Department's Consumer Rights Committee. She also served on the NC State Democratic Executive Committee for 10 years. She was a member of Ross Grove Baptist Church in Shelby, where she served as a deacon, trustee, teacher, member of the church choir, and various other positions in the church. She was the first woman to be elected deacon in her church.

She is survived by her husband of 67 years, Roy Donald Dedmon of Shelby; one son, Rodney Kevin Dedmon, Sr., and wife, Myra Royster Dedmon; grandson, Rodney Kevin Dedmon, Jr., and wife, Kristyn Funderburke Dedmon, and grandson Kristopher Charles Dedmon, all of Shelby. She is also survived by two siblings, sister, Doris Spangler Dedmon, and brother, James C. Spangler and wife, Carolyn Branton Spangler, all of Shelby. She was preceded in death by her sister Sadie Spangler Wright.

The family will receive friends prior to the service from 12 until 2 p.m., in the sanctuary. Funeral service will be held at 2 p.m., on Saturday, July 30, 2016, at Ross Grove Baptist Church, officiated by the Revs. Joshua Hunt and Marcus McGill. Burial will be in the church cemetery.

DENNIS WAYNE GILBERT September 2, 1950 ~ October 19, 2016




