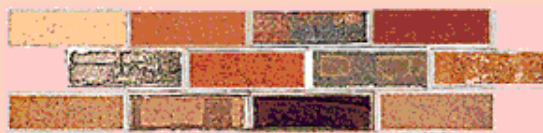
## **Captain Gustavus DEDMAN**

The 2nd Kentucky Infantry was part of the 1st Kentucky "Orphans" Brigade. Captain Gus is listed with 3 others of the 2nd Kentucky Infantry: Dedman, Captain Gus Co. "I" .

## In the Mailbag

*I wrote Teresa Bean regarding her inquiry in issue #10: Teresa, do you have any info on Arty Carolina Dedman . We have a Arozena Caroline Dedmon married to an Unknown Bomen. She was born in Rutherford County NC abt. 1833. Please let us know.. thanks, Leroy..*

I discovered her name on the death certificate of my great grandfather, Elijah Moloney Bowen, listed as his mother. His father was James Y Bowen, the Y possibly stands for Young. On the census, I found out that she was born in NC and her parents were born in SC. James was born in VA as were his parents. I found their tombstones listed on the Hardin County, TN website cemetery census. It is known to have some errors, but it lists her as born October 16, 1832 and dying December 28, 1915. James was born August 11, 1829 and died October 20, 1910. I am very eager to learn more of your Arozena Caroline Dedmon. It seems likely that she is my ancestor. I am planning a trip to Hardin Co, TN in October and hope to find out more about my Bowen and Spencer lines, and perhaps more about the Dedmans as well. It has been a bit difficult to trace James Bowen and his wife due to their travels. I know that he was born in VA, but not which county(the name James Bowen is very common in VA). I know he married Arta Caroline Dedman around 1850. Their first five children were born in Miss, the sixth in Ill, and the last three, including my great grandfather, in Hardin County, TN. I have not found them on the census in VA or Miss. Let me hear more from you on your Arozazina. If she is my Arta Caroline, this may lead me further in my search for the parents of the elusive James Bowen and on into Arta's line. Let me know if I can be of any more help. ## From the Mail Bag



I was glad to see that you are Church of Christ! My family and I are members of the church and worship at the Pennville Church of Christ. Robby Eversole is the minister here and before him was Jim Lewis. Mr. Lewis is now with a congregation in Tennessee.

I can't be sure that the story of Henry, Malissa, and Mattie has not been colored over the years because my aunt that told me will be 88 in October. Her memory still seems sharp as a tack though. All I really know about them is what I told in the letter and that they were married in Walker Co., GA. Saturday I did find Malissa on an 1880 Dekalb Co., Alabama census report living with her father Anderson, mother Bethany and brothers and sisters. Malissa was 20 years old, which would have made her about 28 when she married Henry instead of 19. Martha (Mattie) was 14. I don't know where they lived after their marriage, but I presume, they lived in Catoosa County.

It is such a shame the 1890 census was destroyed, because much of the information could be found there. Do you know anything about when Henry died or what happened to him after Malissa died? My aunt now says she thinks they might have had children together. It seems almost impossible that they would not have had children together unless she became ill immediately after they married.

One thing that interests me about the article from the Catoosa Co. Heritage book is that you say many of William Dedmons descendants went to Arkansas. Well, recently I was doing some research on the Crawford side of the family, Crawfords married Peppers. I seem to have lost my great great great grandfather Crawford. My aunt kept saying they were all from Arkansas and they had all went back there. I checked all the counties with the names I was looking for on the census reports and there are no Crawfords anywhere in Arkansas that even come close to what I'm looking for. So, I thought maybe she has them confused with the Dedmons. Also you say several moved on to California. I have always been told Oscar Peppers, Mattie and Henry's alleged son, moved to San Francisco, California.

I will appreciate any information you have that might help me with my search. I will be glad to furnish you with anything I have on the Peppers that might be of interest to you.
