### CELEBRATING 50 YEARS: FRANK'S RESTAURANT GIVES PERSONAL TOUCH by Chet Folkes Special to The Advocate JUL 7, 2014 - 2:04 AM

Lovingly prepared dishes, cordial service, friendly atmosphere, a vast menu and "the best biscuits in the world" are keys to the success of Frank's Restaurant which observed its 50th year of operation on May 28. The big, bustling eatery at 8353 Airline Highway in Baton Rouge has provided lavish breakfasts and hearty lunches to a diverse crowd of customers representing some of the area's top shakers and makers in the political, industrial and business world. Open at 5 a.m. seven days a week, it averages 500 customers a day who enjoy the menu's large selection of down-home fare. The two dining rooms can accommodate up to 200 people.

Founded by Frank Dedman Sr. and his wife, Carolyn, on May 28, 1964, the business was originally known as the Blue Bird Drive-In and was across Airline Highway from the current location. It's now in its third generation of family ownership and is beginning its fourth generation of loyal customers.

The business has been owned by Frank Dedman Jr. and his wife, Cathy, since 1999. Their three children, Jennifer Guerin, Frank Dedman III and Ross Dedman are all involved in its operation. Their son-in-law, Brent Guerin, is manager. The family opened a similar restaurant with an identical menu, also called Frank's, at 17425 Airline Highway in Prairieville in 2004 with a separate building housing a large reception center. Frank Dedman III and Ross Dedman operate the Prairieville restaurant. Their sister is responsible for the business details and payroll for both operations.

Citing the success of the business, Frank Dedman Sr. said, "We're a family operation, and we've always given it a personal touch. We've built up our business through the years by getting to know our customers, remembering how they like their eggs, remembering what they wanted. Our waitresses — all of the servers — have to be professional. They've built up a real fellowship with their customers through the years."

Although practically every Louisiana-style dish is available, Frank Dedman Jr., cites the restaurant's large, light, creamy buttermilk biscuit as the culinary super star of the establishment's large and diverse menu. He said his father worked on the recipe for a year after beginning the business to get the biscuits "just right."

Frank Dedman Jr. said, "We like to call them the best 'homemade' biscuits in the world," citing statistics that prove Frank's customers' unwavering affection for one of the South's most treasured foods. They make 600 to 700 buttermilk-style biscuits every day, requiring 70 pounds of flour daily and gallons of buttermilk.



"We begin rolling them out at 3 a.m. when the family arrives," Dedman said. "They're then placed in the refrigerator so they can be baked as needed. That way they're always good and fresh."

Some diners use the large biscuit, which come two to a serving, as a base for their meal, especially at breakfast, ordering them with ham or sausages; with chicken fried steak or Cajun-style shrimp or with a choice of grilled cheese. For a sweet treat the biscuits are available stuffed with strawberry, blueberry or apple filing topped with powdered sugar.

Among Frank's most popular items through the years are the six hot lunch daily specials, which include a fried seafood plate, red beans and rice with homemade sausage and chicken fried steak. In addition to the hot meals, the menu offers soups, salads, gumbo, po-boys, sandwiches and every possible breakfast choice, including omelets, pancakes and French toast. And Cathy Dedman said, "If a customer wants something special, and it's not on the menu, we'll try to prepare it."

In the late 1980s the Dedmans purchased a building on an adjacent lot and turned it into a large smokehouse which supplies a variety of smoked meats and fresh sausages for the restaurant. The smoked products, which include brisket, ham, turkey, whole pigs, ribs and turducken, are also available directly to customers.

As a young man, Frank Dedman Sr. was introduced to the restaurant business working for the family who owned the three Hoppers Drive–In operations in Baton Rouge. After holding several positions through the years at Hoppers, Dedman decided to go out on his own, opening the first Blue Bird Drive-In on Airline and later one on Nicholson Drive and another on Plank Road. He made his own ice cream at the Airline location, supplying it to all of his locations.

The 1950s-era drive-in concept with car-hops serving ice cream, milk shakes, sandwiches and burgers was fading by the mid-60s, Frank Dedman Sr. said, and he wanted to make a complete change. Few places were selling biscuits, so he decided to switch from ice cream and shakes to biscuits and breakfasts. He opened at 5 a.m. to catch the early workers on Airline, and served lunch later in the day, but not evening meals.

The big breakfast concept caught on, the customers came and the business prospered. He changed the name to Frank's in 1972, and in 1983 purchased a tract across Airline and to construct the 5,000-square-foot building that now houses his eatery. "The area around Baton Rouge has the best food in the world, and Baton Rouge people really know good food. They know what they like," Frank Dedman Sr. said. "That's what makes the restaurant business so very competitive here."

"We're a family operation, and we knew we had to work hard and offer a personal touch to encourage business," he said. "In addition to our good food, we've always had professional servers, many have been with us for years. We made it our business to know our customers and develop a personal relationship. That's what built our business." He added, "We know our business can't be franchised because it takes a personal touch in addition to the food. The style of our business has stayed the same, and it's not going to change now. When you have a winner, you stay with it."

#### FRANK'S RESTAURANT TAKES ITS FAMOUS BISCUITS TO LOCAL STORES

Served with homemade apple butter, sausage gravy, country ham and more, buttermilk biscuits are the cornerstone of Frank's Restaurant. But, says the son of the founder, the winning formula didn't happen overnight. "It took my dad about a year after he opened to get that recipe down," says Frank Dedman Jr., who runs Frank's with his wife, Cathy, and their adult children. "Eventually, he did and biscuits became our bread and butter. People love the fact that we deliver them hot."

Frank's Baton Rouge and Prairieville locations each serve around 600-700 biscuits daily, he says. The third generation of Dedmans is further expanding their biscuits' popularity. Frank Dedman III has led the launch of Frank's biscuit mix, which went on sale in the restaurant about six months ago and is now also in Hi Nabor grocery stores. The team hopes to scale up distribution in other independent supermarkets soon, Dedman Jr. says.

About 18 months ago, Dedman III began working with Blendco Inc. in Hattiesburg, Mississippi, to perfect a dry formula that would mimic the taste of Frank's biscuits. It took a year of working with food scientists to get the formula right, he says. Blendco produces 5,000 pounds of the biscuit formula every month and a half for use both in the restaurant and in retail sales, says Dedman III. He is also working on packaged take-and-bake biscuits and is interested in wholesaling the products to other restaurants. Talks are underway now with a food manufacturer.

# ANNA (HANNA) DEDMON

The Anna (Hanna) Dedmon Grave is located in No. 6 Township, Cleveland County, N.C. on her plantation <sup>1</sup>/<sub>4</sub> mile south of Metcalf Station on Lawndale Ry., about one mile west of Zion Baptist Church. A large cedar tree stands at head of grave. There is no other grave. She requested to be buried here on her own land.

Anna Dedmon's maiden name was Miss Anna McEntire, and a sister of Bayard McEntire. She was married to Jess Dedmon, and the U.S. Census for Cleveland County of 1850 gives following data: Jess Dedmon, b. 1805; Anna Dedmon, b. 1806; Hezekiah Demon, b. 1837; Elizabeth Dedmon, b. 1844

Jess Dedmon was son of Mark Dedmon. According to data supplied by Veterans Administration, Washington, D.C., "Mark Dedmon was a Rev. War pensioner, Claim W.3960. Mark Dedmon was born Aug. 15, 1758 in Baltimore County, Maryland, and when a child, was taken to Rowan County, North Carolina; the name of his parents are not known. While a resident of Rowan County, N.C., Mark Dedmon enlisted Aug. 5, 1779, served three months in Captain Lions' Company, Colonel Locke's North Carolina Regiment and was at the taking of several Indian towns; he enlisted in the fall or winter of 1780, served in Captain Niten's and William Wilson's companies, under Major McDowell, in the N.C. Troops and was in the Battle of the Cowpens; he enlisted in 1781, and served three months in Captain Haden's and in Captain Niten's company of Calvary under Major Smith in the North Carolina Troops. In 1786, he moved to Greenville District, South Carolina, where he lived one year, then moved to Rutherford County, North Carolina, where he was residing when he was allowed pension on his application executed Sept. 12,1834; he was pensioned in name of "Mark Dedmon! He died March 23, 1839. "Mark Dedmon was married in 1784 or 1785, to Hanna, maiden name not known, and place not stated." "Hanna Dedman, widow of Mark Dedmon, was allowed a pension on application dated January 27, 1842, at which time she was a resident of Rutherford County, N,C., and gave her age as 76 years. In 1848, she stated that she was aged 84 years." The following data are shown-family data: "Polly Dedman, b. Nov. 13, 1786; Thomas Dedman, b. Jan. 15, 1788; William Dedman, b. Mar. 12, 1791; Sally Dedman, b. Sept. 29, 1793"

Old land deeds show that Jacob Christman conveyed to Mark Dedman 100 acres of land on First Broad River adjoining lands of John McEntire Feb. 8, 1795. Mark Dedman settled in Zion Baptist Church community, No. 6 Township, Cleveland County (formerly Rutherford, County), where he reared his family and died, and it is said that he was buried in said graveyard, namely that of Zion Baptist church, as that church was organized about 1814.

She had several brothers and sisters and one was named Burgess, which may be the one in question. (2) Jess Dedmon was the grandson of Mark Dedmon. He was the son of Thomas Charles. (3) Mark's wife Hanna was Hannah Bailey.

That may not be much to correct, but once it makes the rounds it could very well get all out of shape. It is much easier to keep it right, than try to correct the many hunderd or thousand times it may be copied and posted by others. I hesistate to say this, but I am not a huge fan of Ancestry.com, and canceling my subscription. As my cousin and fellow researcher says, "We give them our research and then they charge us to use it". That is my surmise also. I like FindAgrave.com and the last time I checked it is still free. I also like newspaper.com, but it is not free and I use the trial period as often as they will let me. I appreciate all of you who share your work with me and I will reciprocate.


