EDWARD DENTON "ED" DEDMON by Tim Dedmon

Ed was born March 31, 1900 in Hornville, Eastdale,

Chattanooga, Hamilton County, Tennessee, the youngest son of William James Dedmon and Rebecca Ellen McElhaney. His brothers and sisters were Goldie Gertrude (b. Aug 1889), Flossie Marie (b. Sept 1892), Thomas Crawford (b. Nov. 1895), Mark Rufus b. Sept 1898, Mary Alice b Feb 1903. His parents moved from their home in Eastdale to a farm in the Hixson community around 1907. In 1920, Ed's parents moved their family to 217 Winchester street in North Chattanooga. In the 1920 Census William is listed as Treasurer of a Timber Company with Ed and his brother Mark listed as loggers. Ed married Ollie Jane Taylor in Chattanooga on December 21, 1920. Ollie was the daughter of Thomas Levi Taylor and Matilda Moore and she was a fine christian lady.

Edward and Ollie had five children, Mary Elizabeth (b. Jan. 1927), Billy L. (b. Apr. 1928), Charles Edward (b. Jan. 1930), Doris Edwina (b. Dec. 1931), James (Jim) Allen (b. Jan. 1934). Mary Elizabeth and Billy L died at birth and are buried in the Hixson Cemetery. Ed was my grandfather and died one month after I was born, he was the Pastor of the Daisy Church of God for several years and Harry L. Whittington was pastor of the North Chattanooga Church of God. When Ed and Harry would travel to Whiteside and different communities and preach to help start up new churches, Rev. Whittington would visit Ed and Ollie at their home on Winchester Street. Ollie would always cook him a coconut cake, he loved Ollie's cocoanut cake and always said it was the best cake he had ever tasted. While traveling and preaching Rev Whittington's daughter, Eva Mae. would go with them and sing and play the piano when she was just a child.

Eva Mae would later marry Urias LeFevre in 1934, and become "The Queen of Southern Gospel Music" with the LeFevres. On March 31,1942, Ollie was cooking Ed a special birthday dinner for his 42nd birthday when her wood stove caught on fire and burned their house down at 210 Winchester Street in North Chattanooga. World War II started and in the 1942 Chattanooga City Directory Ed appears working at The TNT Plant in Chattanooga. Later in 1942 Ed moved his family to Rockwood, Tennessee and worked at the Manhatten Project in Oak Ridge, Tennessee, where they made the Atomic Bomb. After the War was over Ed moved his family back to North Chattanooga and started working again as a collector for Fowler Brothers Furniture Company where he had worked since 1933.



Ed bought a house at 606 Van Dyke street in his old neighborhood in North Chattanooga in 1946. He would practice his Sunday sermons on the front porch and his sons Charles and Jim would go around the side of the house and mimic him. Ed liked hunting and my father, Charles Dedmon, would tell stories about Ed hunting with his coon dogs. One day we were talking about Ed hunting and Dad said that Ed would go hunting every summer in Panama City, Florida, and I askd Dad what he was hunting for in Panama City and he said "two legged Dear". I can remember talking to my mother Gail Reed Dedmon about my grandfather, Ed, and her telling me in her exact words "All the ladies catered to Ed Dedmon and he catered right back". My father also told me that Ed drove a car across the Tennessee River when it froze over.

I remember asking an old timer, William Neely, who grew up in the neighborhood on Houser Street if he had ever heard the story of my grandfather driving a car across the Tennessee River when it froze over and he said, "Tim, it wasn't a car, it was a Model T Ford and everyone in North Chattanooga knew Ed Dedmon drove his Model T Ford across the Tennessee River when it froze over". Dad said that Ed wasn't a big man but he was very strong. They had a full grown horse named "Old Blue" they had owned for years who was old and very gentle. One day while living on Winchester street, Dad said Ed stated since "Old Blue" had been carrying him around for years that he was going to carry "Old Blue". Dad and a crowd of neighbors watched as Ed got under "Old Blue", pulled in his hind legs and then reached around his front legs and pulled them in and started walking down Winchester Street carrying "Old Blue". Ed had back trouble in his late forties and Doc Sherman gave him a prescription for the pain. Ed's daughter Doris told me that Ed sent her to refill his prescription at Doc Sherman's Drugstore at the corner of Manning Street and Cherokee Blvd and Doc Sherman told her that her father was taking to many of the pills (Yellow Jackets) and he would not refill the prescription again. Ed was hospitalized and died within two weeks, on January 9, 1951 being fifty years old.

Tim connects with me at William Dedmon, the son of Mark Dedmon, who was a Revoultionary War Veteran. Mark was the first known ancestor to spell our surname DEDMON. We are definately blood kin via DNA testing. We are direct descendents of

KRISTEN DEDMON Head Varsity Coach Bishop Amat Memorial High School th<u>e Archdiocese of Los Angel</u>es



Kristen Dedmon - Head Varsity Coach Kristen Dedmon begins her 2nd season as the Lady Lancer's head softball coach. In her first season the team posted an overall 18-10 record, and 9-3 in the Del Rey League. Before joining the Lancers, Coach Dedmon was the head varsity softball coach at Capistrano Valley High School for the past three seasons. Prior to joining the Cougars, Kristen served as an undergraduate assistant coach for UCLA in 2008.

As a player for the Bruins, Dedmon played in 129 games during her four-year career, making 95 starts. She hit .225 with seven home runs and 41 runs batted in, with her best season coming in 2005 when she had six homers and 26 RBI. Her most dramatic hit as a Bruin though came in her freshman season of 2004 when she had the game-winning, pinch-hit RBI on a two-run single in the fifth inning against California to lead the Bruins to winning the NCAA Division I Women's College Softball National Championship.

Ms. Dedmon has a Bachelor of Arts degree in political science and history as well as credentialed in English. She will join the Amat faculty teaching English, World History, and PE Softball.

I followed Kristen's college career with several articles about her success as a softball player and applaud her efforts and success as a teacher and coach. When her father played for the Atlanta

#### BOAT CAPTAIN'S WIFE: EMOTIONAL WOUNDS YET TO HEAL By Justin Juozapavicius Published: May 27, 2007

TULSA, Okla. - Some days, when the heartache comes, Joe Dedmon asks God why he's still alive. It's been five years since 14 people died after the barges being pushed by his towboat crashed into the Interstate-40 bridge near Webbers Falls, causing a 500-foot span to collapse into the muddy Arkansas River. Yet each anniversary has been a little more difficult for Dedmon, a man who grew up on the river, only to watch it turn against him in the cruelest way possible. The details of May 26, 2002 are still too painful for him to talk about publicly, says his wife, Betty, from the couple's home in Mississippi.

Joe Dedmon would later tell investigators he blacked out before the barges hit the bridge, sending cars and trucks splashing, one by one, into the river, their victims trapped inside. A nearby fisherman fired a warning flare to alert motorists a part of the bridge was out, but the damage was done. "It's getting closer to that day, and he kind of gets down and out," Betty Dedmon says of the approaching Memorial Day weekend. "The days are very hard for him." Most painful for Joe, she says, is knowing there are people who still believe her husband, who has an abnormal heart rhythm, didn't black out at the wheel moments before the accident.

She's saved newspaper clippings from the days and weeks following the accident, offering up all the theories of what could have happened in that wheelhouse. That's why Joe hasn't been able to bring himself to read any of them, she says.

"I do want people to know it has broken him really bad and it's something he'll never get over," Betty says. "It will always be with him." Even though the National Transportation Safety Board's 92-page final report said Dedmon's heart condition most likely caused him to lose consciousness moments before the accident, that's no consolation for him, she says. Dedmon cannot make a living. He surrendered his pilot's license after the crash and spends most of his days with his grandchildren.

"God saw fit to leave him here for a reason," Betty says. Also spared that day were Broken Arrow evangelists Max and Goldie Alley, who came within 8 feet of a watery grave. They sometimes ask the Lord why they lived and so many others perished, but to them, it's a matter of faith. Five years ago, their pickup drove off the collapsed bridge, landing on a section that had not fallen into the river. Max broke his back in two places; Goldie had cracked ribs. But they were alive. So this weekend, as they have for the past four years, they will cross that rebuilt bridge to preach at a tiny church near the Arkansas border. This year's sermon will be about the tricks of the Devil. "When God spared my life five years ago, I know he wasn't finished with us," said

Goldie Alley, who has traveled with her husband to nearly 200 churches across the country since the accident to share their testimony. There are days she gets the survivor's guilt, the "why me, Lord?" moments, but she says they quickly pass. "We'll never forget that, it makes you thankful each and every morning you get out of bed," she says.

The tragedy also took years off the life of Gary Ridley, the state's transportation director, whose job it was to oversee the rebuilding of the I-40 bridge and make certain a disaster like Webbers Falls never happened again in Oklahoma. Oklahoma has more than 1,000 state-maintained deficient or obsolete bridges over water, out of 6,700 total. Ridley, who joined the department in 1965, cites progress since 2002. Legislation passed last year will allow the transportation department to pour more resources into fixing and replacing bridges, as well as other roadwork.

Before the bill was passed, the agency only had the means to replace 145 bridges during the next eight years. Now, the number is up to 480. As for the four major bridges in the McClellan-Kerr navigational channel, the department has or will install 50 protective concrete piers in front of the structures to protect them from runaway barges. The concrete piers are already in place at the I-40 bridge. "We wanted to ensure ourselves they were adequately protected from someone else making the same mistake," Ridley said in a recent interview. "Buy us some peace of mind."

More changes could be coming, too. The U.S. Coast Guard is still reviewing recommendations set forth in the NTSB report about evaluating the utility and effectiveness of wheelhouse alerter systems on towing vessels to prevent further accidents, a spokesman said.

For Joe Dedmon, there could come a day when he is ready to talk about what he's been through, his wife says. Just not this year. "We just really want the people there to know we still pray for them and ask for their forgiveness. "God's the only one that can heal this for all of us," she says.
