He is a graduate of Warren Wilson College, Middle Tennessee State University, and Vanderbilt University School of Law. He has taught prosecution training courses in almost every state. He developed the training courses for the National Advocacy Center in Columbia, South Carolina, which focused on analytical advocacy, a concept developed at the



Career Prosecutor Course in Houston, Texas, for the National College of District Attorneys. He also developed the NDAA Courtroom Technology courses. He has written many of the training materials used by NCDA and later NDAA as well as articles and chapters in prosecution publications. He has received the Lecturer of Merit award, the Distinguished Faculty award, the NDAA President's award, the Lifetime Education Achievement Award from the Florida Prosecuting Attorneys Association, and an honorary gold record from the Recording Industry Association of America. He is licensed and admitted to federal practice in Tennessee. He is a Vietnam Veteran and served in the United States Army Special Services Entertainment Division. Were hearts grieving as prayers are said and songs are sung? Did many hats tilt for you as the men walked away? Days and perhaps weeks go by and they come back again to say "Hello" if only for a few moments only to say "Good bye" again. Then your visitor goes home. As time passes the visits get fewer and fewer ,only to become no visits at all. You thought you were forgotten, you weren't.



Some stones here are more than 200 years old now, many even older still. You all may think you have been left behind as generations pass you by. Weather and Time are putting marks upon your stones. Some of you are breaking , Some of you have fallen to the ground from where they once stood. Some are leaning. Some have sunk into the ground. Some are Rocks with your names etched upon them . Some have been etched with a knife. Yet some, Though they are dirty and covered with moss, are still standing tall.

I want you to know that you are not forgotten, even after so many years . Your names are written down in the families bibles, and your children's names too. I would bet even your grandchildren can be found in many books.. You are talked about in family journals. I wish I could read some of those just to read about you. Just to read about the way you all lived back then. To read about how you worked. How you played. What Sundays were like. What school was like. I want to know it all. If I could only get my hands on old family journals. I have no journals so all I can do is look at these gravestones and let my imagination take me to the 1700 and 1800's.

Until then my search continues for every journal, every book I can find about you. I want you to know you are also included in many family trees. Your descendants are many, so, know that you are not forgotten. Your memory is so cherished by so many. Your stories are well sought after and many are seeking it to this day.

As I sit here I see many of these headstones really clearly , many you can't read at all. What happens with those you can't read? I wonder how will future generations find you? They have to find you just like I did. I know others will come looking, I know somebody will come looking for you. I came looking for you. You don't know me , but I know you. I'm your 8x's Granddaughter . And I'm your 7x's Granddaughter. And I'm your 6x's Granddaughter. And 6x-7x- 8x Grand Niece to all of you. 
