

CONGRATULATIONS FOR A CENTURY OF SERVICE

I have written about the historic Beaumont Inn several times, but they have reached a milestone and deserve mentioning as they have reached a fanstic number of years for the Inn to be in the Dedman Family. A special slate of events were scheduled for July 19- July 21, 2019 during the "Beaumont Classics Weekend". No doubt it was a week-end to remember. The Beaumont Inn has been in the Dedman family for five generations and one hundred years. There will be a special invitation only party to celebrate the 100th Anniversary of the Beaumont Inn on September 21, 2019.

Constructed in 1845, the building which is now the Main Inn at The Beaumont Inn was a school for young ladies of our grandmothers' and greatgrandmothers' day. It was owned by Dr. Samuel Mullins and operated as Greenville Institute until 1855. For the next forty years, the school was known as Daughters College and was under the direction of Mr. John Augustus Williams, former president of the University of Kentucky.





In 1894, the school was bought by Colonel Thomas Smith, veteran of the army of the Confederate States of America. The school operated as Beaumont College until 1916. It was purchased by Mr. and Mrs. Glave Goddard in 1917 and converted by them into the Beaumont Inn two years later. Now, almost a century afterward, descendants of the Goddards continue to refine the art of southern hospitality. Here in a park-like setting of centuries-old forest trees, serenely remote from the cares of the work-a-day world, the fourth and fifth generations of the family now open the doors of The Beaumont Inn to welcome guests to their heritage and hospitality

Beaumont Inn has been honored with numerous hospitality and food awards, including the prestigious James Beard Foundation America's Class Award (the Oscars of the food world). In January 2019, the Beaumont Inn and Innkeeper Dixon Dedman were featured in The New York Times in an article celebrating Kentucky Owl Bourbon and the history of the Inn. At the end of 2018 and early 2019, the Inn's southern food, history, and traditions were explored by Kentucky Living Magazine, Kentucky Monthly Magazine, and the Kentucky Visitor's Guide. In April 2019, Southern Living Magazine once again named the Beaumont Inn one of the South's best places to stay. The Beaumont Inn is also an official stop on the Kentucky Bourbon Trail and provides tours from the Inn to the nearby distilleries. Shaker Village of Pleasant Hill and Centre College are also within quick driving distance



Bandits Ask Man For Drink; Take Him for \$12 Ride

John D. Deadmon can always wonder what would have happened if he had given a drink to the man who asked him for one early today.

As it was, Mr. Deadmon, 44, of 3710 Ninth street N.W., had no drink. The man gave a low whistle; summoning a parked automobile containing two or more men who, at gunpoint, took his \$12 and then kept him in the car for a small tour and one more robbery.

At 718 H street N.E. two of them got out, held up a Little Tavern night manager, Larry Kephard, 635 F Street N.E., in full view of an assistant and four customers, and walked out with \$75.58. Mr. Deadmon was still in the car at gunpoint.

At Third street and Florida avenue N.E., they put him out of the car and sped away. He noted the license number, but the tags had been stolen earlier in Baltimore, police learned.

"I had merely told the guy I didn't have a drink, but knew where I could get some," Mr. Deadmon told police.

Man's Robbery Story Leads to 3 Arrests -- Including His Own --

The holdup of a Northeast sandwich shop early yesterday was genuine enough, but police refuse to accept one man's version of it and charged him and two others with robbery.

John D.Deadmon, 44, of the 3700 block of Ninth street NW, told police he was robbed of \$12 by three men, who then forced him to accompany them while they robbed the Little Tavern in the 700 block of H street N.E., of \$75.58.

While police broke down his story in day-long questioning yesterday. Prince Georges County police were rounding up the two men accused with him.

Once Worked at Shop

Police said Deadmon admitted having a part in planning the robbery and that he supplied the weapon used, but did not enter the sandwich shop because he had once been employed there and feared he would be recognized.

Lobbie Delman Harris, 28, of Baltimore, was arrested by Pvts. Adam J. Lindsey, John L. Tucker and David F. Dudley and Corpl. Roland Sweitzer, near Ardmore, Md., about 1 p.m. Vincent Woodrow Bateman, 25, also of Baltimore, who was in a car with Harris, fled on foot and was found shoeless and coatless in the woods three hours later by County Detective Richard A. Pearson and Metropolitan Detective Sergts. Tom Harty and Edwin Crandall and Lt. Otto Fuss. Prince George police said they found a .32 caliber revolver in the car. A fourth man is sought.

Denies Part in Robbery

In Municipal Court before Judge Walter J. Casey this morning, Bateman, who appeared with only one shoe on, admitted stealing the car in Baltimore, but denied taking part in the robbery. He told the court he was "so drunk" he didn't know what was going on. Harris admitted his part, implicated Bateman and Deadman and a fourth man, identified only as "Bob." All were held for the grand jury on bonds of \$10,000 each.

Judge Pine sentences John E, Deadmon, 44, of the 3700 block of Ninth street N.W., to serve from one to three years in jail for his participation October 18 in a \$75 robbery of a Little Tavern shop in the 700 block of H street N.E. Two other men had been sentenced previously in the robbery and a fourth had been acquitted.

Geo. R. Dedman Seriously Hurt

Geo. R. Dedman, of the Golden North hotel sustained very serious injuries this morning at 11 o'clock, while attempting to straighten out a door on the wood house at the Golden North Hotel on Fourth street, which had become bulging by the frost. He placed a crowbar under the door and tried to lift it into place, but in doing so raised the rollers off the runway at the top and the strong wind that was blowing at the time, caused the heavy door to fall on Mr.Dedman throwing him to the ground underneath it. Mr.Dedman was injured so badly that he was unable to extricate himself, but the accident was witnessed by Rev. Pedersen, who hurried across the street and released him. In the meantime, Messrs, Latham and Tanner had arrived on the scene and Mr. Dedman was taken up and conveyed to the Golden North Hotel. Dr. Brawand was summoned and found upon examination that besides a severe bruise and cut on the forehead, some of the ligaments of the back had been torn from the spine. At this writing the extent of Mr.Dedman's injuries is not known.

Teachers Contract Issued in 1806 Is Owned by Kansan

Special to The World..ELK CITY, July 29.

R.A. Howard of this city has in his possession a very unique, interesting paper. It is a copy of a school teaching contract made by Howard's grandfather, Elijah Deadman, in 1806, to teach a school in Oldem county, Kentucky. Howard is the only living grandchild of Deadman.

The Contract follows

We the subscribers, do hereby oblige ourselves, our heirs, etc., to pay or cause to be paid to Elijah Deadman, his heirs, etc,. nine shilling for each and every scholar annexed to our names, which member we are to continue for and during the term of three months from the beginning of the school and for all the time made over and above we are to pay for in proportion to be paid as follows, viz,: One-fourth in money, the balance in whiskey, salt, wheat, beef, pork, sugar, or linen at the market price on or before the expiration of said three months delivered at said Deadman's house.

And the said Deadman shall duly attend his school five days in every week for and during the said term of three months and use his best diligence to learn and instruct his scholars to the best of his knowledge and to make good all lost time at the expiration of said three months or by keeping on Saturdays if he is so minded to do. The school to begin on the 27 day of August, 1806. Then follows a list of nine subscribers, with a total of 16 pupils.

Masked Men Forced Entry



For the other one we have to leave the "Lower 48" and journey to Alaska.in the Fairbanks area there is also a Deadman Lake and Deadman Bay. There are some Deadman Mountains in Canada and Russia and other places designated Dedman, such as Deadman Flats, Deadman Lake, and Deadman Pass. Some of these if not all are named for the treacherous terrain and known as dangerous places such as Deadman curve.

Dead Man's Flats is a hamlet in Alberta. A variety of explanations account for the origin of the hamlet's name. One explanation associates it with a murder which took place in 1904 at a dairy farm situated on the flats of the Bow River. François Marret stood trial in Calgary for killing his brother Jean, whose body he had disposed of in the Bow River, but the jury acquitted him by reason of insanity.

ELIZABETH KITTIE "LIBBIE" DEDMAN




