[Dedmon] Family Gathers For Birthday Party for “Uncle” Wilson Clements in 1933

Very proud members of the Park, Yandell, Dedmon, Clements, Cavender, Collins, Shahan, Magill, Beck, Shaw, Chapman, Castleberry, Warrenfells, and other lines gathered on September 8, 1933, to celebrate the birthday of “Uncle” Wilson Clements who was in

his mid-’90’s at the time. This photo was taken in the yard of the Old Home Place of the Park-Clements-Cavender families in Villanow, Walker Co., GA, which was the location of the Park-Clements-Cavender Cemetery, also. The Home Place and Cemetery are on the same road as the historic “Joseph Warren Cavender General Store at the main crossroads of the center of Villanow, GA.



Located between those two family landmarks was also a home which was built by James Clements and became in more recent years the Summer home of Myrtis Cavender Shahan (one of the four daughters of J.W. Cavender). Her son, Maxwell Shahan is pictured, sitting on ground, in second row. Maxwell lived into his late ‘90’s until his death at his home in Knoxville, TN, in the last three years. Myrtis Cavender Shahan is the lady who is standing on the far left of the 3rd row. The attempt at identifying all of these gathered family members was made by Llewellyn Chapman, Frank Clements Shaw, and myself, Eddie Hightower — all descendents of James Park and Martha Yandell Park.

Sitting on the ground in the first row is Myrtis Shaw, who is the mother of young Frank Clements Shaw, Jr., seen sitting in his mother’s lap, then James Clements, next is Charles Clements, and May Clements who is being held by her mother. Sitting on the bench are four family members. The first lady is either Lilian, or Julia Clements, the next lady is Mary Park Clements who is a daughter of the “BIRTHDAY BOY” who is seated to the right with cane in hand and wearing a handsome white beard in coat and tie. To “Uncle” Wilson’s right is Clementine Castleberry.

The lady standing in the 3rd row next to Myrtis Cavender Shahan just may be Adelaide Beck Chase (daughter of Georgia Cavender and Benjamin Beck), but we are not absolutely sure of this. Next to her is Nannie Clements Shaw, and the gentleman to her right is Haskell Castleberry, Sr., next is Minnie Cavender Warrenfells and her only brother Judson Cicero Cavender (the Grandfather of Eddie Hightower and Judson R. Hightower). Seen on the back row, peeking between Aunt Minnie and Judson, is the wife of Judson Cavender, Flora Collins Cavender. The two gentlemen and one lady on the back row, standing with my “Granny Flo” Cavender have not yet been identified by Llew, Frank, nor myself. We need your help, please!

Eddie Hightower obtained this photo and help in the identifications from our Cousin Frank Clements Shaw, Jr. on his visit to Frank’s home at Davis Cross Roads in Kensington, Walker Co., GA, on Aug. 1, 2005. Coincidentally, I had in my possession two other photos including some of the same family members along with others not in this photo which were passed down to me from my mother, Martha Eleanor Cavender Hightower. She was the only daughter of Judson C. and Flora Collins Cavender.

It appears from all the dates and markings on the three photos in question, that they were all taken with the same camera and developed at the same time in a studio in Chattanooga, TN, on Oct. 4, 1933. But this is not an absolute certainty. I will pass along the other two photos with attempted identifications in a later e-mail. Thanks for your patience and I hope that you have appreciated this visit with our long departed “Uncle” Wilson Clements who served the CSA wounded so well on the battlefields of the South.

May God Bless all of you, Eddie Hightower, son of Martha Eleanor Cavender, grandson of Judson Cicero Cavender, great grandson of Joseph Warren Cavender, Great Great Grandson of Dr. Adam G. Clements and Mary Wilson Hill Park, and Great Great Great Grandfather James Park and Martha Yandell.

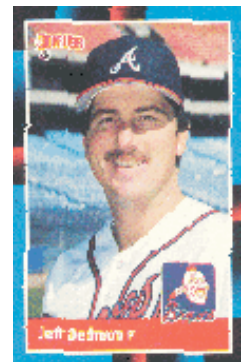

To get to this cemetery from Forest City, NC go east on E. Main St. and after you cross the river bridge go to the second right or exactly opposite of East Rutherford High School. The cemetery will be about two to three miles on the right. If on highway US-74 go north at the Ellenboro-Henrietta exit, go to second left, look for sign. This cemetery is in two parts, the oldest is the one across the other road and most distant from the church. This is a well maintained cemetery. I started the inventory on February 22, 1997. I started in the old part away from the church in the northeast corner and worked toward the west. The inventory was completed February 24, 1997. Some unreadable markers and quite a few unmarked graves. The new part, or part next to church, was started in the south west corner.

HAPPY BIRTHDAY LEON



The Coast Guard-manned USS *Serpens* was laid down under Maritime Commission contract (MCE hull 739) on 10 March 1943 by the California Shipbuilding Corp., Wilmington California. She was launched on 5 April 1943 and was sponsored by Mrs. H. P. Needham. She was transferred to the Navy on 19 April 1943, renamed *Serpens* and designated cargo ship AK-97. She was commissioned at San Diego on 28 May 1943 under the command of LCDR Magnus J. Johnson, USCGR.

Following shakedown off southern California, *Serpens* loaded general cargo at Alameda and, on 24 June, sailed west to assume provision ship duties in support of operations in the Solomons. By mid-July, she was in the Tonga Islands. At the end of the month, she was en route from New Caledonia to New Zealand and, by mid August, she had emptied her holds at Wellington. She then took on more cargo, returned to New Caledonia, and commenced a series of short hauls to Vitu Levu, Tutuila, Penrhyn, Bora Bora, Aitutaki, and Tongatabu. On 9 November, *Serpens* returned to New Caledonia.

In early December, she moved into the southern Solomons, and, after completing a Florida Island-Banika Island run, she stood off Lunga Point, Guadalcanal, to load cargo for Bougainville. During January 1944, she completed two runs into Empress Augusta Bay. In February, she was ordered back to New Zealand for dry-docking before loading dry provisions. For the next four months, *Serpens* delivered consignments to bases in the New Hebrides and the Solomons, returning to New Zealand to reload only once. In July, she was at Purvis Bay for the installation of a SF-1 radar. LCDR Perry L. Stinson, USCG, took over command from LCDR Johnson on 22 July 1944.

She then resumed operations and, through October, carried general cargo and rolling stock between ports and anchorages in the Solomons. In mid-November, she loaded repairable vehicles from the Russells and from Guadalcanal and sailed for New Zealand where, after off-loading, three of her holds were converted for ammunition stowage. Late in December 1944, the Liberty ship commenced loading at Wellington, finished it at Auckland, and returned to the Solomons in mid-January 1945.

On the 29th, she was anchored off Lunga Beach. The commanding officer and seven others, one officer and six enlisted men, were ashore. The remaining crewmen were loading depth charges into her holds when the *Serpens* exploded. After the explosion, only the bow of the ship was visible. The rest had disintegrated, and the bow sank soon afterward. 198 Coast Guard crewmen, 57 Army stevedores, and

a Public Health Service physician, Dr. Harry M. Levin, were killed in the explosion and another soldier who was ashore was killed by shrapnel. Only two of those on board, SN 1/c Kelsie K. Kemp and SN 1/c George S. Kennedy, who had been in the boatswain's locker, survived.

An eyewitness to the disaster stated: "As we headed our personnel boat shoreward the sound and concussion of the explosion suddenly reached us, and, as we turned, we witnessed the awe-inspiring death drams unfold before us. As the report of screeching shells filled the air and the flash of tracers continued, the water splashed throughout the harbor as the shells hit. We headed our boat in the direction of the smoke and as we came into closer view of what had once been a ship, the water was filled only with floating debris, dead fish, torn life jackets, lumber and other unidentifiable objects. The smell of death, and fire, and gasoline, and oil was evident and nauseating. This was sudden death, and horror, unwanted and unasked for, but complete."

LCDR Stinson reported: "I felt and saw two flashes after which only the bow of the ship was visible. The rest had disintegrated and the bow sank soon afterwards." The two survivors, SN 1/c Kemp and SN 1/c Kennedy, according to Stinson, "...showed a lot of savvy by grabbing a couple of water lights that we kept stowed in the [boatswain's] locker. They used them to attract attention when they climbed out onto the floating portion of the bow." Both men were injured but were rescued by a base commander in the area.

At first report the incident was attributed to enemy action but a court of inquiry later determined that the cause of the explosion could not be established from the remaining evidence and by 1949 the Navy noted that the loss was not due to enemy action but due to an "accident intrinsic to the loading process." The loss of the *Serpens* remains the largest single disaster ever suffered by the Coast Guard. The dead were initially buried at the Army, Navy and Marine Corps Cemetery at Guadalcanal. Their remains were later exhumed and taken to Arlington National Cemetery where they were interred on 15 June 1949. A large monument in their honor was erected over the grave site and dedicated on 16 November 1950.

Among those missing following the explosion was: **DEDMON, John Clifford, Jr.; Radarman 3/c** The *Serpens* earned one battle star for her World War II service.

Mr. Dedmon is an expert on the aviation industry. He has been involved in the aviation business since 1969. He has testified before a U.S. House of Representatives' Sub-Committee and also has participated in crash investigations and engine tear down inspections with both the FAA and NTSB.

Mr. Dedmon graduated from Rice University in 1965 with a bachelor's degree in economics and later from Southern Methodist University with a master's degree in business administration. He began his career in the aviation business in 1969 when he joined Superior Air Parts, Inc., where he held the position of vice president. His responsibilities included marketing, product development, Federal Aviation Administration regulatory compliance, product liability insurance matters and litigation. In 1985 he became president upon Superior's acquisition by NEOAX, Inc.

In 1990, Mr. Dedmon formed Aircraft Technology Corporation, Inc., and served as its president until its sale in 1998. AirTech's primary business was designing, engineering, manufacturing and distributing FAA approved replacement parts for aircraft engines.

Since the sale of AirTech he has worked as a consultant for Aviation Consulting Group, Inc., where he provides consulting services with regard to FAA regulations in the area of product certification, engineering and manufacturing. He also provides consultation involving product liability insurance, exposure and litigation.

Dedmon has testified as an industry expert before a U.S. House of Representatives sub-committee that was investigating competition in the aviation replacement parts industry. He has given presentations at a number of FAA sponsored events. He has also actively participated in aircraft crash investigations and engine tear down inspections with both the FAA and the National Transportation Safety Board. He has been involved in product liability litigation and anti-trust litigation.
