I AM GOING TO MAIL THEM TOMORROW

When I preached on Sunday morning, July 14, 2013, I did not realize it would be my last sermon to preach at Ooltewah. We got in the car to meet some friends for lunch, but that never happened. As I put the car in reverse things begin to spin. I managed to get it into park and close my eyes as the nausea had already begun. A couple of the elders were still there and managed to get me into a wheel chair and inside the building. They then called 911 and the ambulance arrived shortly and transported me to Memorial Hospital. Gwen arrived a couple of hours later (the time it takes to drive from Buchanan to Chattanooga). I don't remember how long the elders and their wives stayed with us, but pretty sure it was until Gwen arrived. Other friends, including Mike and Judy Caputo and also my nephew, Brian and his wife, Cindy arrived on the scene. By the time I managed to get home the decision had already been made that we were going to have to move to Buchanan.

For three months I lived in Gwen's recliner (day and night) and was only able to go to the bathroom and the car to go to the doctor with help of another person and a walker. By the end of October, we were able to move into the house next door to Gwen and have been here a year. In March of 2014 after two stays in the hospital and five trips to Emory in Atlanta for therapy to restore my "balance" (no comments please), I was beginning to get around on my own fairly well. I told Gwen, I felt I could preach some if the local churches needed a "fill in" when the regular preacher was away. I wrote a letter and she and the grandchildren stuffed and addressed the envelopes. In a few days I received two calls to "fill in". When I told Gwen I had already two appointments, she said, "*Those letters must be working*". I replied, "*They may be, I am going to mail them tomorrow!!!*" I have never completely understood how the providence of God works, but it seems He was a couple of steps ahead of me. To say the least I have had a busy year.

I have conducted four Gospel Meetings (revivals) at Cowan, TN; Buchanan, GA; Lumley Stand in Manchester, TN; and Greenbrier in Ashland City, TN. In addition I have preached several Sunday "fill ins" and also a number of Wednesday nights. These include: Bremen, GA (Sunday and Wednesday), Cookeville, TN; Trenton, GA; Lafayette, GA; North Cherokee in Walaska, GA; Buchanan, GA and Bowdon, GA. I have had to cancel two appointments I made as I was not able to go when the time came. These were Lithia Springs, GA and Pennville in Trion, GA. I also teach a class on Sunday Morning at Buchanan. I have also taken "Preecher" Alfalfa Hayseed to Lafayette, GA and the Lions Club in Buchanan. I am still experiencing some health problems and have a biopsy coming up within three days of the time of this writing. We will know something soon....

When I first began this research project, I was very fortunate to find Jim Dedmon, a cousin, who lives in Fresno, CA. He had done extensive research on the family the hard way in BC (before computers). He was unselfish and shared with me his findings. I was privileged to meet him when we had our very first reunion in Chattanooga. He and Harrison Dedmond traveled together and met up with some more cousins in Atlanta (they lived in Florida and were Harrison's brothers and families). I met them at the Cracker Barrel in Kennesaw, GA and then later when we assembled at the Chattanooga Valley Church of Christ in Flintstone, GA. We have stayed in touch through the years via email. Our common ancestor is William D. Dedmon, my great grandfather and his great great grandfather. I was glad he and Harrison was able to meet my mother and exchange stories. Another avid researcher was Gordon Black, also a cousin from the William D. Dedmon line, who lived in Ringgold. He and Jim had corresponded many times prior to my meeting them. Gordon had boxes of information, which he shared with me. He was also related on my maternal side of the family, therefore providing me with much material on the Dickson, Black and Templeton family.

His son, Jim Dedmon, Jr. is a financial advisor for Wells Fargo Advisors in the Fresno, California area and active in other things as seen in the column to the right. In Volume 8 of **THE DEDMON CONNECTION**, I published a special picture of Jim, Sr., sent to my by his son. He lost his wife to a battle of cancer a few years ago and I have wished I could have been there for support. It is amazing how close I feel to all of my cousins found through this research even though in many cases we have never met.

Recently, I was paid a very memorable visit by three of my "found" cousins. **Susan Dedmon Miller, Judy Dedmon and Liz Dedmon Cook**, who are sisters and also cousins via the William D. Dedmon connection. They came through Buchanan and met Jane and myself for lunch at Gwen's (our daughter) Family Restuarant. I dedicated Vol. 77, to their father, **Roy Lane Dedmon**. Our paths have crossed so many times through the years and yet we did not know of each other's existence until about 15 years ago. Although we have communicated by email and facebook, it was the first time we met.

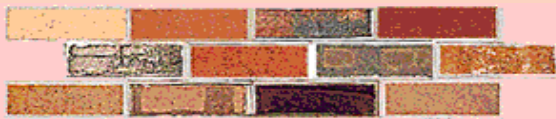
This is Jesse Dedmon, my grandson who won two Grand Champion trophies in San Jose, CA He is nine years old.

THE BRICK WALL



I have discovered at least five major Deadman branches that we have not been able to connect. If you have information on any of the Deadman family branches, please submit.

We (all known family researchers) have searched in vain to find the connection to the Christopher Deadman line of the Deadman family. Many of us believe such a connection does in fact exist. Wanda Colvin made a trip to England and found records on both lines in the same place, but could not locate the link we need. Christopher was born around 1625 and died in York County, VA in 1679. There are several sons of John Thomas Deadman who would have been the right age for Chris' father and we have none of their descendents. These would include Charles Thomas (b. 1598), William Lane (b. 1600), Robert H (b. 1604), James T. (b. 1605), and Henry (b. 1607).

The best I can tell of the "West Tennessee" Dedmons is they descend from Christopher and moved west from Virginia via Alabama. I found the following at FindAgrave.com:

**George Washington Dedmon
(b. 1840 AL, d. 1900 TN)**

In my files I have a George W. Dedman, son of William Dedman, born in Madison, County, AL and dying before 1903 in TN. I believe George Washington Dedmon is in fact George W. Dedman. His family is traced back to Virginia and to Chris.

However, this entry caught my eye since since he was born in N. C., that places him closer to our line (geographical speaking)

**J F Dedmon, (b. Apr. 10, 1857- d. Jun. 20, 1886)
"BORN IN DAVIE CO, N C APR 10, 1857"**

**Husband of Sarah Polina VanEaton Dedmon
They were both buried in Good Hope Cemetery;
Dyer, Gibson County, Tennessee, USA**

However, the records we have show Sarah Paulina Van Eaton married to James Anderson Deadman on Feb 09, 1854 in Davie County, NC and is buried in Gibson County, TN. but, J. F. Dedmon is her son (John Franklin Deadman). Her husband died in Richmond, VA in 1863 (probably in the Civil War). He was a descendent of John Deadman, which raises the possibility of other WestTennessee Dedmons also being of that line instead of Christopher's.

I was honored by being asked to speak at Linda's funeral service, but due to illness was unable to do so. The Dicksons were some of our closest cousins growing up. We were actually kin on both sides of the family. According to Family Tree Maker, she was my 2nd cousin, 3rd cousin once removed and 4th cousin. This was because her great great grandmother was Mary Hannah Dedmon. Although her father, Alex Dickson, was my mother's 1st cousin, we called him "Uncle Alex". During my pre-school years and part of the first grade we lived near each other at Graysville, GA. The day my father left for the Army, my grandfather was hit by a truck and passed away two days later. The Red Cross arranged for him to meet us in Macon, GA and since mom did not drive "Uncle Alex", drove me and mom to Macon. When we moved from Graysville to East Garden Farm Road near Rossville, GA, Paul walked our cow the approximate 15 miles. It was not long after that when he joined the Armed Services at the young age of 16 and in a short time was reported as Missing In Action in Korea. He was never found. In my senior year of high school, I had the family car with a load of friends in Graysville and went down a dirt road where a rock bursted the oil pan. It was near a recreational area and Carl Dickson happened to be there. He had a welding shop nearby and towed us to the shop and repaired the damage. I thought I was "home free" and dad would never know, but at the next oil change the attendant pointed the repair out to dad and I had to "face the music". At some time, "Uncle Alex" was employed at the amusement park known as Lake Winnepesauka and operated the "bumper cars". When I and my friends would ride, he always let the time go longer. He served many years in law enforcement in Ringgold. The Dicksons were among those who visited mom during her illness prior to her passing away. As is the case with many cousins time has separated us to some extent and although we are not as close as we were in our childhood years, our love for the family is still there.
